## General contractual statement of entrants and drivers

The participants assure that the information given in the entry form is correct and complete, and that the vehicle entered complies in all respects with the applicable laws, regulations and technical provisions. Furthermore, it is assured that the driver is able to cope with the requirements of the racing competition without any restrictions.

By signing the entry form, the entrant/driver further declares that

- he/she has taken note of the FIA International Motor Sport Regulations with appendices, the ACCR Regulations for Circuit Racing, the other FIA and ACCR regulations as well as the present Notice of Race.
- these rules and regulations become part of the entry contract with the consent of the participants
- these rules and regulations are accepted as binding and will be followed
- the stewards of the event and the ACCR Courts are entitled, within the limits of their jurisdiction, to impose penalties in the event of infringements.
- the participant expressly consents to the performance of an alcohol or doping test by an authorised doctor at any time during the event on the instructions of the stewards. Refusal to do so will result in exclusion from the event.

## Declaration by competitors and riders on the exclusion of liability for slight negligence and on the exclusion of strict liability

**1) Responsibility:** The participants (applicants, drivers, motor vehicle owners and keepers) take part in the event at their own risk. They shall bear sole responsibility under civil and criminal law for all damage caused by them or the vehicle they use, unless an exclusion of liability is agreed in accordance with this invitation to tender.

**2) Disclaimer:** Participants understand and fully accept all risks and dangers of motorsport. Should a participant be injured during an event, he/she expressly declares by submitting his/her entry for this event that he/she approves of any medical treatment, rescue, transport to hospital or other emergency services. All such measures will be taken by personnel appointed by the Organiser for this purpose, to the best of their knowledge and in their estimation of the participant's condition. Participants agree to pay all related costs, unless covered by the licence accident insurance or other insurance policies.

The participants therefore waive, for themselves and their legal successors, also for any insurance company with which they may have concluded additional contracts, any direct and indirect claims for damages against the ACCR, its officials, the promoter or organiser or circuit owner, as well as any other person or association involved in the event (including all officials and authorities or organisations issuing permits for the event), as well as other competitors and drivers, collectively referred to as the "Parties".

Entrants, by submitting their entry to this Event, irrevocably and unconditionally waive any and all rights, remedies, claims, demands, actions and/or proceedings that may be brought by them or on their behalf against the "Parties". This in connection with any injuries, losses, damages, costs and/or expenses (including attorneys' fees) incurred by the participants as a result of any incident or accident arising out of this event. Participants, by submitting their entry to this event, irrevocably agree to release, discharge, exonerate, protect and hold harmless the "Parties" from liability for any such loss at all times.

By submitting their entry for this event, the participants declare that they understand the full meaning and effect of these declarations and agreements, that they freely enter into these obligations and thereby irrevocably waive any right of action based on damages against the "Parties" to the extent permitted by Czech law. The participants waive for themselves and their legal successors in any case against the "Parties", therefore in particular against the ACCR, its officials, the promoter, organiser or race track operators, or against the authorities or organisations issuing permits for this event, all claims concerning damages of any kind whatsoever that are connected with the typical sporting risk, in particular all typical and foreseeable damages. This also applies in the case of slight negligence on the part of the "parties".
